We have more than 80 years of experience working with landowners. Let us help you save on your Managed Forest Plan while conserving one of our most important natural resources: wetlands.

DUC will provide a 40% reimbursement (up to \$600) to landowners who complete a Forest Management Plan with a Managed Forest Plan approver.

To be eligible, landowners must:

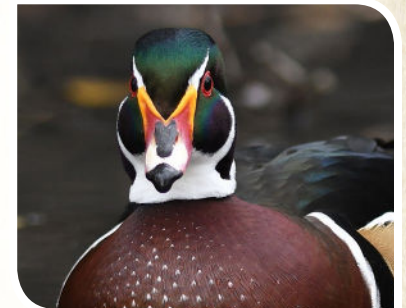
- + complete a Managed Forest Plan through MFTIP with a Managed Forest Plan Approver
- + have an existing wetland (minimum five acres/two hectares identified in their Managed Forest Plan) that provides waterfowl habitat
- + be located in one of the DUC/MFTIP eligible areas (*see over for map*)
- + commit to conserving wetland habitat by signing a DUC conservation agreement

Ontario wetlands provide critical habitat for waterfowl and other wildlife, including species at risk. Wetlands also help clean our air and water, control flooding, mitigate the effects of climate change and foster healthy communities.

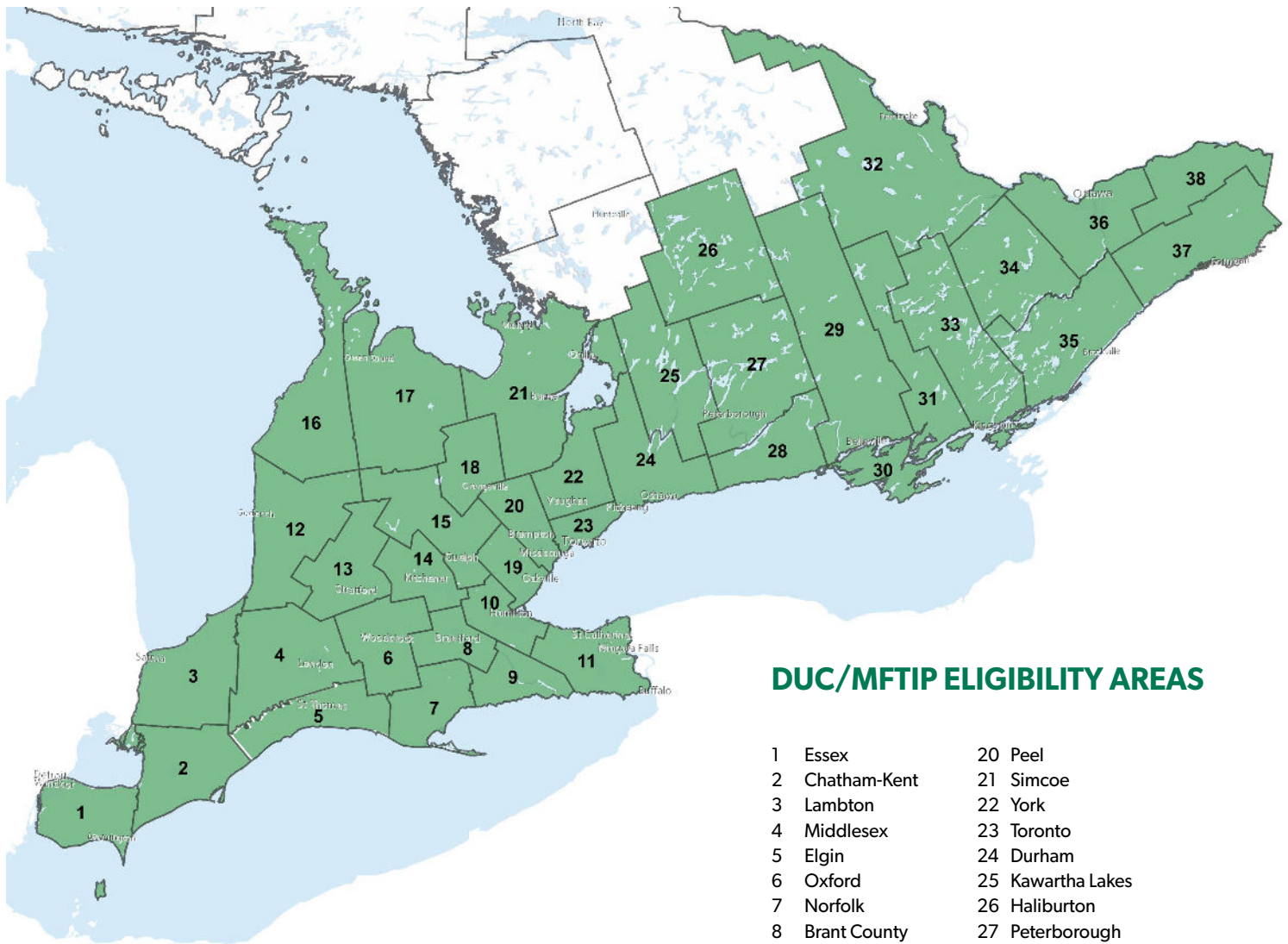
